### 备注:

1、根据议定书:冷冻羊肉产品指带骨羊肉或/和剔骨羊肉,不包括内脏。

According to protocol: Frozen Lamb refers to the bone-in or/and boneless of slaughtered sheep excluding offal.

2、冷冻牛肉指冷冻剔骨和带骨可食用牛肉(牛经宰杀、放血后除去毛、内脏、头尾及四肢(腕及关节以下)后的骨骼肌,不包括横膈肌、碎肉、下脚料、机械分离肉及其他副产品)。

Comment: Frozen Beef refers to frozen deboned or bone-in bovine skeletal muscles from which the hair(fur), viscera, head, oxtail and feet (below ankle and wrist) are removed after slaughter and bleed. The tonic tissue (diaphragm), trimmings, scrap, mechanically separated meat and other byproducts are also required to be removed.
